## NOTICE OF PUBLIC HEARING AUGUST 27, 2021 10:00 a.m. – 2:00 p.m. PDT

## ANIMAL CONFINEMENT

On May 28, 2021, the California Department of Food and Agriculture (CDFA) jointly with the California Department of Public Health (CDPH) proposed regulations to adopt sections 1320 through 1327.2 of Chapter 10 of Division 2 of Title 3 of the California Code of Regulations. Specifically, the proposed adoption establishes a regulatory framework to implement Health and Safety Code sections 25990 through 25994, Farm Animal Cruelty (Proposition 12). In 2018, California voters passed the Proposition 12 initiative which set forth farm animal confinement standards.

The Notice of Proposed Rulemaking for the proposed regulations was published in the *California Regulatory Notice Register* on May 28, 2021 [Notice File No. Z2021-0518-22, Register 2021, No.22-Z] and initiated a 45-day public comment period. The CDFA and CDPH received requests to hold a public hearing on the proposed regulations.

The CDFA and CDPH will convene a public hearing on August 27, 2021 beginning at 10:00 a.m. PDT and the hearing will continue until 2:00 p.m. PDT. The hearing will be held remotely and will not have a physical location. The CDFA and CDPH will accept oral or written statements during the hearing. Oral testimony will be limited to two (2) minutes per speaker. [Government Code section 11346.8] The hearing will be recorded.

This public hearing is a listening only session for the purpose of accepting comments regarding the proposed regulations, therefore CDFA and CDPH will not be responding to the public's comments or answering questions during the hearing.
